Meeting Minutes

November 16, 2023

I. Call to order:

Chairman Turi called to order the regular meeting of the Goshen Fire District at 7:00 PM on November 16, 2023 in Goshen, NY. III. Approval of minutes from last meeting:

Chief Wade: Absent

Assistant Chief Easop:

Assistant Chief Graham:

- Shabad has requested the use of the ladder on December 7 to light the Menorah
- Had a Mass Casualty Drill at the Jail and the stand pipes are bad. As of right now all stand pipes at the jail are out of service.
- Hazardous waste information had wrong numbers and didn't even say to call the fire department. Addressed this with Chief Tankasali.

VIII. Old Business:

- Commissioner Donnelly met with Greenlight with regards to what firehouse they felt would be the best to put their equipment. Station 2 looks like the best option. They would use the Fire Police room and the Fire Police would move back downstairs.
- Commissioner Pearson reported that the Pumper/Tanker specs are done and need to go to the lawyer to be reviewed. The cost of will be \$1,357,0342 because of new regulations by the NFPA. If we put 75% down we will get a discount of \$167,252.00. Will have chrome rims due to the weight and axle.

IX. New Business:

Upon a motion made by Commissioner Pearson and seconded by Commissioner Donnelly a resolution was made to change the LOSAP Program as follows:

> Lower the entitlement age from 62 to 60 Increase monthly amount from \$20.00 to \$30.00.

By doing this the yearly amount would increase approximately from \$130,000 to \$230,000. A roll call vote was taken. Commissioner Turi, Mendres, Shovlin, Donnelly and Pearson all voted yes. Motion passed. (Attachment A)

- A motion was made by Commissioner Mendres and seconded by Commissioner Donnelly to authorize UBS to pay Penflex our annual fee. A roll call vote was taken. Commissioner Turi, Mendres, Shovlin, Donnelly and Pearson all voted yes. Motion passed.
- A motion was made by Commissioner Pearson and seconded by Commissioner Shovlin to allow UBS to reinvest \$137,000 in a 12 month CD at 5.4%. A roll call vote was taken.
 Commissioner Turi, Mendres, Shovlin, Donnelly and Pearson all voted yes. Motion passed.

X. Public Participation:

- Past Chief Budd asked if everyone could please respond to the Cataract Christmas party invitation by November 22. 2023.
- Past Chief Budd asked if we had received any response from Mr. Pinsky with regards to the Incentive Program. Commissioner Turi said we had and that the proposed program was not going to be initiated. The chief's would be taking it over and awards would be given out by the number of calls the attended. (Ex. 10% - shirt, 15% - flashlight). No one would be going to the store to order any item.

XI. Adjournment:

A motion was made by Commissioner Mendres and seconded by Commissioner Pearson to adjourn at 7:35 PM. All Commissioners present in favor. Motion passed.

A motion was made by Commissioner Pearson and seconded by Commissioner Mendres to come back into session as an item was forgotten.

Commissioner Pearson brought up the way points were figured for the Chief's election and asked if a member joined any time after November 1, 2022 that their points would be figured on the time that they were in (ex. If a member joined in May of 2023 their % of calls would be divided on the total number of calls from May to October.) All Commissioner agreed. Secretary Roberts was instructed to look at any new member and to configure their percentage accordingly.

A motion was made by Commissioner Mendres and seconded by Commissioner Donnelly to ajourn at 7:45 PM. All Commissioners present in favor. Motion passed.

RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE GOSHEN FIRE DISTRICT

In the matter of amending the provisions of the Length of Service Award Program adopted for active volunteer firefighter members of the Goshen Fire Department

WHEREAS; qualified electors of the Goshen Fire District approved a proposition to establish a Defined Benefit Length of Service Award Program, with the first program year beginning January 1, 1992, to be administered by the Goshen Fire District Board of Fire Commissioners, for active volunteer firefighter members of the Goshen Fire Department ("Active Members"), in accordance with Article 11-A of the New York State General Municipal Law ("Law"); and,

WHEREAS; under the current Program provisions, volunteers earn a \$20 Monthly Service Award for each year of Service Credit earned under the Service Award Point System up to twenty (20) years of such credit in the Program, with the monthly Service Award payments commencing to the volunteer upon attainment of the Program Entitlement Age of sixty two (62);

WHEREAS; Article 11-A of the Law authorizes the Board of Fire Commissioners to hold a referendum to seek approval for an amendment to the Program; and,

WHEREAS; these amendments may be intended to enable the Fire District to improve the Service Award Program benefits for the Active Members; and,

WHEREAS: such improvement in the Service Award Program benefits is consistent with the intent of the Program to help the Goshen Fire Department. recruit and retain Active Members;

NOW THEREFORE BE IT RESOLVED, that the Board of Fire Commissioners, as authorized by Article 11-A of the Law, directs that there shall be a public referendum of eligible voters of the Goshen Fire District in an election to be held on December 12, 20 23 to seek voter approval to:

increase the Monthly Service Award from \$20 to \$30 for service credit earned effective January 1, 2024; and

change the entitlement age from 62 to 60 that a participant is eligible to start receiving benefits.

BE IT FURTHER RESOLVED, the current program calendar year 2023 cost of the Program will be about \$130,000 or about \$634 per participating volunteer, which includes the annual cost of administration of about \$10,600. Should voters approve this amendment, the annual cost of the amended program for current participants is estimated to increase to about \$230,000, or \$1,122 per participating volunteer. There will be no increase in administrative fees expected because of this amendment; and

BE IT FURTHER RESOLVED, all other provisions of the Program which require voter approval shall not change and the Program shall continue to be administered in accordance with Article 11-A of the Law as such law is amended from time to time.
