Meeting Minutes

December 21, 2023

I. Call to order:

- A motion was made by Commissioner Mendres and seconded by Commissioner Donnelly to go with the hourly rate of \$400.00 with Pinsky Law Firm. Commissioner Turi, Mendres, and Donnelly voted yes. Commissioners Pearson and Shovlin were absent. Motion passed
- A motion was made by Commissioner Mendres and seconded by Commissioner Donnelly to have a commendation letter from the board and the Commendation letter from the chiefs placed in the individual folders of the FAST Team that saved the Warwick FF Life. Commissioner Turi, Mendres, and Donnelly voted yes. Commissioners Pearson and Shovlin were absent. Motion passed
- Upon a motion made by Commissioner Mendres and seconded by Commissioner Donnelly a resolution was made to purchase a new Pumper/Tanker and necessary equipment in the amount of \$1,500,000 from capital fund following permissive referendum. RESOLUTION OF THE GOSHEN FIRE DISTRICT

Whereas, the district has a need to purchase a new pumper/tanker;

Whereas, sufficient reserve funds have been saved in a capital reserve fund which may be utilized to purchase the apparatus;

Whereas, spending funds in a capital reserve requires the resolution to be subject to permissive referendum;

NOW THEREFORE, upon motion made, seconded and discussion held, and **subject to permissive referendum,** the fire commissioners of the fire district RESOLVE as follows:

- 1. There is hereby declared a need to purchase a pumper/tanker utilizing funds from an appropriate capital reserve fund;
- 2. The district shall purchase the apparatus utilizing funds from the capital reserve fund;
- 3. Up to \$1,500,000.00 may be withdrawn from the capital reserve fund for the payment of a pumper/tanker and appropriate equipment. The withdrawal may be taken in one or more amounts;
- 4. No funds may be withdrawn until the passage of thirty days from the date of publication of the abstract of the publication of this resolution;
- 5. The secretary is hereby directed to place an abstract of the resolution upon the town's sign board and website immediately, and must remain there for at least 15 days;
- 6. The secretary is hereby directed to place such abstract in the newspaper having general circulation in this district.

This resolution was approved by a majority of the Commissioners, on the 21st day of December, 2023.
